GREEN CHANNEL FACILITY

We congratulate you on being selected as a BOI Green Channel Facility holder. This achievement is on account of your excellent performance on compliance with BOI Regulations pertaining to imports and exports relating to your business. We trust you would maintain the same standards in your future activities as well.

As a Green Channel Facility holder, your Company will be granted priority and a fast track service in processing your import / export documentation. Further, only one out of ten import /export consignments will be verified.

You are requested to please adhere to the following requirements, with regard to the Green Channel Facility granted to your enterprise;

1. Cargo cleared from the Colombo Port / Airport should be taken directly to the enterprise and not to any other location.
2. Notify the respective Verification Unit, the receipt of cargo at the enterprise premises within 03 days from the date of clearance of same from the Colombo Port / Airport.
3. Any shortcomings in documentation detected at the post-audit should be rectified within 03 days after notification.
4. Any shortages or excess receipt of undeclared cargo, incorrect cargo should be notified to relevant service centre within 03 days.
5. Import cargo consigned to zonal enterprises, should be declared at the "In-Gates" of the Export Processing Zones and at the Verification Units prior to removal of same to the enterprise.

The responsibility for the accuracy of import export document, accuracy of cargo imported and exported solely lies on the enterprise. BOI and Sri Lanka Customs have the right to examine cargo allowed under Green Channel Facility, if deemed necessary.

The Green Channel Facility granted to your Company will be effective from the date of this letter until it is revoked.

We will look forward to your ideas and views on further improvements that can be made by us in facilitating your work and also how we can encourage more establishments to emulate the high standards that you have maintained in the past.


